2.1 Who are Nature Path, Inc., and the ThetaHealing Institute of Knowledge®?

We are Vianna Stibal and Guy Stibal. We live near Idaho Falls, Idaho. We are the owners and officers of the corporation Nature Path, Inc. After Vianna developed ThetaHealing® and began practicing and teaching it full time, it eventually became necessary to organize her activities as a business. So she founded Nature Path, Inc., an Idaho corporation. Nature Path, Inc. does business as the ThetaHealing® Institute of Knowledge™, which is registered as a private trade school with the State of Idaho. Nature Path, Inc. also has a retail store in Idaho Falls called Vianna's Nature's Path™.

2.2 Why are these terms trademarked?

The purpose of a trademark is to let everyone in the world know the source of goods and services that are offered to the public. The owner of a trademark word, phrase or symbol is entitled to prohibit others from using the trademark to sell their own goods and services, because otherwise the public would be confused and misled about who the source of those goods and service is. The trademark system helps to ensure that buyers of goods and services know what they are getting and who they are getting it from. It helps protect the customer from being misled. And, it helps protect the reputation of the owner of the trademark from being damaged by what others do.

Obviously, we are concerned about the reputation of ThetaHealing®. What we offer to students is knowledge. When we have passed this knowledge on to a student, the student is free to do with it whatever he or she wants. A student may add new elements to this knowledge, or take elements away from what we teach. This is fine – but if a student does this, what results, whether it is good or bad, is no longer what we teach – ThetaHealing®. It is something else that we cannot vouch for or have any control over. Therefore, we choose not to have our name associated with it. We prefer to be in control of our own reputation. The trademark system allows us to control what is offered to the public as “ThetaHealing®.” By claiming trademark rights in these words and symbols, we can make sure that only those students who practice and teach ThetaHealing® as we teach it are allowed to use our trademarks and call themselves “ThetaHealers®.”

2.3 How can you use the trademarks if we own them?

A Certified ThetaHealing® practitioner receives a license to use certain of our trademarks. A license is written permission from us granting you the privilege of using our trademarks so long as you comply with the terms of this contract.

2.4 What will be my rights and obligations under this Contract?

By signing this Waiver, Release and Application, attending all class sessions, paying all tuition and other fees required by your Certified Instructor, and successfully completing the course of study, you will be eligible to be recognized by THInK as a ThetaHealing® Practitioner. As a Certified ThetaHealer®, you will be entitled to the following for five years or until your certification is cancelled for failure to comply with the terms of your certification:

You will be granted permission by us to use certain of our trademarks, such as ThetaHealing®, ThetaHealer®, ThetaHealing Institute of Knowledge®, and the names of the classes you are certified in, so that you may hold yourself out as a practitioner of ThetaHealing® who has learned the techniques taught in those classes.

We will list your name, location, contact information and certifications on our website, if you request.

You will be required to practice ThetaHealing® under the terms and conditions set forth in your Certification.

You will be required to attend updated classes or refresher courses or to attend additional classes as a condition of extending your certification beyond five years. (this can be helping assist a teacher, and it is just to assist you in giving your clients the most you can)

On completion of this class, your instructor will send us your information and your completed application. Your instructor will issue your certificate then send your paper work to us to be recognized of Certification as a Practitioner of ThetaHealing®, which will include your License to use our Trademarks, and the Terms of Practice. The terms of practice, terms of the license agreement and other miscellaneous terms that will be part of your Certification are available from your Instructor. Please review them. When you receive your Certification, your practice as a ThetaHealer® and your use of our trademarks will be subject to the terms and conditions in the Certification.
